Call to Order: Chair, Debbie Ricks called the Clay County Development Authority ("CCDA") Board meeting to order at 4:00 PM.

Invocation: William Randall

Approval of September 18, 2013 Minutes: Greg Clary made motion to accept; Matt Welch seconded and motion carried.

Oath of Office of new officers for 2013 - 2014, Debbie Ricks, Chair, Chip Dobson, Vice Chair and William Randall, Treasurer were sworn in by Counsel, Grady Williams.

Proposed Resolution No. 2013/2014-01 re Policy on Public Meetings pursuant to F.S. s. 286.0114 (2013) was discussed. Joe Mobley made a motion to adopt the Resolution; Greg Clary seconded and motion carried.

Comment from the Public: Joe Riley commented that Bill Garrison and Betty Hicks had been very cooperative in providing assistance with his requested information regarding CCDA and Big League Dreams.

Ken Smallwood, Developer, advised that a direct contact with parties that may be interested in the purchase of the DevCom building could be made without having to list the property.

Treasurer's Report: Cam DiFrancesco reviewed and discussed the September financials and the Budget for YE2013. A YE2013 Budget amendment will be made and approved at the next board meeting.

Chair's Report: Debbie Ricks held discussion on the transition re Administrative Office Services for 2013/2014 and Organization Infrastructure and Facilities. The subject of selling the DEVCOM building and what options were available were discussed. Jason Hausman, Integrity Consulting Group and Mark Carillon, WEB904 provided information on the public email assignments for the Board members and updating the website. Without objection, it was

agreed that the CCDA Board members will utilize the newly assigned public e-mail addresses, which will ensure archiving and search feature advantages in the future.

The RFP for an Executive Director position was discussed and, without objection, it was agreed that the RFP will be posted on the website and published in the Florida Times Union and Clay Today. Joe Mobley made a motion that the candidates be narrowed down to three (3) for the Board to review and vote on the best candidate for the position at that time; Greg Clary seconded and motion carried. All information must be submitted with the Proposal that is due on Friday, November 15 at 12:00 noon.

Big League Dreams Project Update: Greg Clary advised that negotiations are on-going, but requested a delegation of authority from the Board to extend the due diligence period or terminate big league dreams license agreement. Joe Mobley made motion to authorize Greg Clary to have authorization to extend or terminate the license agreement with BLD. Matt Welch seconded and motion carried.

Attorney's Report: Grady Williams advised he will continue to assist in the transition from the Executive Director role and assist in any matter until that position is filled. A request was made to approve his invoice for services rendered. Motion made by Jan Conrad to approve payment of the invoice; Chip Dobson seconded and motion carried.

Economic Development Council Report: Bill Garrison advised the EDC will continue to assist in the transition of the administrative support, Public Record requests, Open Meetings, Website and E-mail updates. Bill has talked with the County Manager at the Admin Building in the event that CCDA would like to have the board meetings at their location including videotaping with a DVD copy provided for a fee. The CCDA could also tape their own board meetings as they currently do for no fee. Bill announced that a new business will be relocating in Green Cove Springs. It is an International Aviation and Space Company that will bring 15 jobs to start and plans to expand in the near future.

RESOLUTION OF CLAY COUNTY DEVELOPMENT AUTHORITY (THE "AUTHORITY") ADOPTING THE FINAL AMENDED "ADJUSTED TO ACTUAL" BUDGET FOR FISCAL YEAR 2012/2013; AUTHORIZING THE EXECUTIVE DIRECTOR OR ADMINISTRATIVE STAFF TO TAKE OTHER AND FURTHER ACTIONS REASONABLY NECESSARY OR HELPFUL IN FURTHERANCE OF THIS RESOLUTION; AND PROVIDING AN EFFECTIVE DATE.

BE IT RESOLVED, BY THE FORMAL ACTION OF THE AUTHORITY, THAT THE FOLLOWING ACTION IS HEREBY ADOPTED AS THE LEGAL AND BINDING ACTION AND RESOLUTION OF THE AUTHORITY, PERTAINING TO THE ABOVE SUBJECT MATTER SPECIFIED.

BACKGROUND RECITALS

WHEREAS, it is necessary and appropriate for the Authority to adopt and publish its final amended budget for Fiscal Year 2012/2013, to correspond to actual revenues and expenditures for that fiscal year;

WHEREAS, the staff and accountant for the Authority have prepared and provide such budget for formal adoption and approval; and

WHEREAS, the Authority desires to fully comply with the provisions of all applicable laws and auditor recommendations to implement and observe best practices in the adoption and amendment of its budgets.

FORMAL ADOPTION OF RESOLUTION NO. 2013/2014-02

NOW, THEREFORE, THE FOLLOWING ACTION IS HEREBY ADOPTED BY THIS RESOLUTION NO. 2013/2014-02, DATED EFFECTIVE THIS 20^{TH} DAY OF NOVEMBER, 2013, AS FOLLOWS:

<u>Section 1.</u> The Authority's official Budget for Fiscal Year 2012/2013, representing the final amended budget for the immediate past fiscal year of the Authority with revenues and expenditures adjusted to actual results for that reporting period, is hereby accepted, amended, approved and adopted in the form attached hereto as Exhibit "A", attached hereto and herein incorporated by reference.

Section 2. The Executive Director or administrative staff of the Authority or his or her designee shall take such other and further actions as may be reasonably necessary or helpful to the action authorized, approved, and adopted by this Resolution No. 2013/2014-02, and as may include, for purposes of illustration and not limitation, (a) informing the auditor of the Authority of the approval of the amended final budget for Fiscal Year 2012/2013, (b) publishing the final amended budget for Fiscal

Year 2012/2013 on the Authority's website, and (c) filing the same with the Clerk for the Board of County Commissioners for Clay County, Florida.

Section 3. This Resolution 2013/2014-02 shall be effective immediately upon adoption.
